SECTION 4 FIRST AID MEASURES

IN CASE OF INHALATION

Remove from exposure and move to fresh air immediately. If breathing is difficult, give oxygen. Get medical aid. SAFETY PRECAUTIONS

ENGINEERING CONTROLS
